

# 2023 ZEISS IQS Academic Program Scholarship Contest Official Scholarship Rules and Regulations

1. THERE IS NO FEE AND NO OBLIGATIONS NECESSARY TO ENTER OR WIN THIS SCHOLARSHIP. ENTRIES ARE LIMITED TO ONE PER STUDENT. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

### 2. Eligibility:

- a. The ZEISS IQS Academic Program Scholarship Contest is open only to legal residents of the fifty (50) United States and the District of Columbia, who currently reside in the U.S., and who are at least eighteen (18) years of age or older on the date of entry. Employees of Carl Zeiss Industrial Quality Solutions, LLC ("ZEISS"), its affiliated companies, participating sponsors, sales agencies, suppliers, sales representatives, distributors, resellers, subsidiaries, advertisers, advertising agencies, public relations agencies, and other companies associated with the promotion of the scholarship, and their respective parents, subsidiaries, affiliates, advertising and promotion agencies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to apply or win the scholarship. - b. Applicants must be an active part-time or full-time student currently enrolled in or in an accredited institution. Applicant must be enrolled full or part-time at an accredited institution between January 1st, 2023 and December 15th, 2023. Applicants must be currently enrolled in a metrology, machining, or engineering program.

6. Scholarship Selection and Announcement: A team of judges will review all entries as they are received, up until the deadline of December 15, 2023. Each entry will be judged on the creativity, knowledge of metrology, and how well they demonstrated their knowledge. The contest scholarship winners will be selected and announced during the contest, as determined by the judges, to be fully selected and announced by Friday, December 22, 2023 (the "Scholarship Selection and Announcement"). Closing date for entry will be December 15, 2023 at 11:59:59 PM CDT. Entries that are submitted after the Scholarship Deadline will be disqualified. The winner will be notified by email and/or letter within 90 days of selection. If the winner cannot be contacted or does not claim the prize within 14 days of notification, the Sponsor reserves the right to withdraw the prize from the winner and pick a replacement winner from future entries.

#### 7. How to Enter

a. In order to qualify, applicants must complete the required documentation of the 2023 ZEISS IQS Academic Scholarship Contest (the "Application"), the flyer found at www.zeiss.com/metrology/campaigns/zeiss-academic-program. Each student must complete all required fields listed on the Application form. The applicant must submit a final video (the "Video") and the Application form designating themselves and representing institution, both electronically to the location provided in the instructions. The Sponsor is not responsible for lost, late, incomplete, garbled, stolen, misdirected, returned, non-deliverable, illegible entries, or problems of any kind whether mechanical, human or electronic. All entries are the property of the Sponsor, and no entries will be acknowledged or returned. Limit of one (1) entry per person, per email address, prior to the deadline of the Scholarship. Limit of one scholarship per person. Entries received from any person, or email address in excess of the stated limitation will be void. ## 8. Distribution of Awards:

- a. Five winning (5) students will be awarded a one-time, \$1,000 scholarship (per student) for qualified expenses, including undergraduate tuition, fees, books, and on-campus room and board for the 2023-2024 school year. Scholarships awarded to all students are to be applied to qualified expenses, including undergraduate tuition, fees, books, and on-campus room and board for that school year. A (one) free CMM calibration will be awarded to the institution of the winning student, judged by ZEISS to be the best. If any winner cannot accept the scholarship as stated for any reason, the scholarship will be forfeited and awarded to an alternate winner. No scholarship transfers, assignments, cash equivalents or substitutions will be allowed.
- b. Funds and calibration are provided directly by Carl Zeiss Industrial Quality Solutions, LLC. Payments are issued by Carl Zeiss Industrial Quality Solutions, LLC, made payable to the student and mailed after the winner is announced. No cash alternative to the prizes will be offered. The awards are not transferable. Awards are subject to availability and Carl Zeiss Industrial Quality Solutions, LLC reserves the right to substitute any prize with another of equivalent value without giving notice. - 9. **Responsibilities of Recipients:** The recipient must be actively enrolled full or part-time as an undergraduate freshman, sophomore, junior, or senior at some time between January 1, 2023 and December 31, 2023 and for an entire academic semester without interruption, barring illness, emergency, or military service. It is the recipient's responsibility to verify receipt of funds with their designated institution and notify Carl Zeiss Industrial Quality Solutions, LLC should the award check not arrive on or after 30 days from the issue date.

- 10. **Institution Approval:** The institution must be accredited and listed on the official website of the U.S. Department of Education. All school transfers are subject to accreditation approval. Applicants must also receive proper approval from their institution for use of the institution's equipment and resources.
- 11. **Disqualification:** The Sponsor may disqualify any individual it finds to be tampering with the entry application or the operation of the Scholarship; to be acting in violation of the Official Scholarship Rules and Regulations, by cheating, hacking, deception, or other unfair playing practices (including the use of automated entry programs), or to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsor or any other person.

#### 12. General Conditions:

- a. In order to claim the award, each student will be required to electronically sign and submit a Declaration of Compliance within seven (7) days of the date of the initial email notification was sent. In signing the Declaration of Compliance, the winner acknowledges they give the Sponsor permission to include a photo of the student in social media posts about the Scholarship. The winner agrees to the use of the student's name and image in any publicity material. Any personal data relating to the winner or any other applicants will be used solely in accordance with current federal and state data protection legislation and will not be disclosed to a third party without the applicant's prior consent.
- c. If any other funds pay entirely the tuition, fees, books, and on-campus room and board for the student's 2023-2024 school year, the student is no longer eligible to receive this scholarship and will forfeit the award.
