System integration service

FORUM® from ZEISS enables you to manage your patient and diagnostic data centrally, and to make your assessments based on the overall clinical data. To achieve this goal, ZEISS FORUM first collects your patient's exam results by linking the diagnostic systems and then making the data available to you.

In order to fully harness the benefits of the data management system, the Electronic Medical Records (EMR) program, Hospital Information System (HIS) or Picture Archiving and Communication System (PACS) must be integrated. This way, gaps or breakdowns in communication are avoided and the workflow is optimized. ZEISS offers all measures that are necessary to enable smooth communication between these systems through the ZEISS system integration package.

Aims of system integration

- Connecting diagnostic systems and patient management systems
- Avoiding gaps or breakdowns in the communication between the systems involved
- Optimizing your workflow and minimizing throughput times

Process

Prior to the system integration, it is necessary to determine which systems should be taken into consideration for connection to ZEISS FORUM. This may involve diagnostic systems such as field analyzers or OCTs which are linked for smooth communication between the individual systems via either DICOM or a proprietary interface of the respective manufacturer. If they are available, HIS or PACS may also be connected. The HL7, DICOM, XML interfaces, or other interfaces are available to achieve this. During a joint definition phase, ZEISS will work with you to determine the interplay of your systems in accordance with your needs and your workflows. In the process,

it is important to take both your existing processes and your IT landscape into consideration. ZEISS experts will explain in detail how your processes can be optimally designed and will advise you on possible extensions and licenses. The conclusion of this phase generates a blueprint in which the desired outcome is described in detail.

The next step involves connecting the individual systems to ZEISS FORUM. For EMR, HIS and PACS systems, ZEISS generally contacts the manufacturer directly in order to coordinate the specific requirements. If necessary, after consulting you, we will carry out the necessary adjustments so that the desired steps can be carried out. These preparations include the following measures:

- ZEISS arranges a test session with the systems affected in order to inspect the existing message types and formats
- Adjustments are carried out on both sides (ZEISS FORUM and EMR/HIS/PACS) until the optimal workflow is reached
- An end-to-end test is carried out to determine if the workflow is working correctly and in accordance with your wishes
- All steps and settings are documented carefully in order to ensure traceability
- You approve the final solution

ZEISS undertakes the project management of this entire process.
